**Existing Rule:**

**3.10.8 Player Releases**

Recreational Player Releases:

Once a player has registered with a Member Association and been rostered to a recreational team, they are bound to that team for the entire seasonal year unless the player is granted a release.

2. A request for a recreational player to be released to another member association for recreational play shall be submitted to and approved by the NTSSA Youth Commissioner in writing on the form provided, stating the reason for the request on the release. Releases to transfer to another member association will be allowed from December 1 up until they are registered and rostered to a team for the Spring season. Releases outside of those dates will be considered only as an exception.

**3.10.8 Player Releases**

Recreational Player Releases: **Transferring Associations Mid-Year:**

Once a player has registered with a Member Association and been rostered to a recreational team, they are bound to that team **Association** for the entire seasonal year unless the player ~~is granted a release~~ **transfers to another association utilizing the following process:**

- 1. A player transfer to another member association may take place from December 1 up until they are registered and rostered to a team in their current Member Association for the Spring season. If they have registered for the Spring season, they are not eligible to transfer, unless an exception has been granted by the Youth Commissioner.** ~~A request for a recreational player to be released to another member association for recreational play shall be submitted to and approved by the NTSSA Youth Commissioner in writing on the form provided, stating the reason for the request on the release. Releases to transfer to another member association will be allowed from December 1 up until they are registered and rostered to a team with their current Member Association for the Spring season. Releases outside of those dates will be considered only as an exception.~~
- 2. The player must submit a completed transfer form to the new association, indicating where they registered in the fall, why they are transferring and in which association they plan to play in the Spring.**

- 3. The receiving association must sign the form, acknowledging the transfer, and provide a copy of the completed transfer form to the original association, informing them that the player will not be returning. They may then register the player.**
- 4. There is no need for the transfer to be submitted to or approved by North Texas, if it is within the transfer window indicated and the player has not registered for the spring.**

**New Rule:**

**3.10.8 Player Releases**

Recreational Player Transferring Associations Mid-Year:

Once a player has registered with a Member Association and been rostered to a recreational team, they are bound to that Association for the entire seasonal year unless the player transfers to another association utilizing the following process:

1. A player transfer to another member association may take place from December 1 up until they are registered and rostered to a team in their current Member Association for the Spring season. If they have registered for the Spring season, they are not eligible to transfer, unless an exception has been granted by the Youth Commissioner.
2. The player must submit a completed transfer form to the new association, indicating where they registered in the fall, why they are transferring and in which association they plan to play in the Spring.
3. The receiving association must sign the form, acknowledging the transfer and provide a copy of the completed transfer form to the original association, informing them that the player will not be returning. They may then register the player.
4. There is no need for the transfer to be submitted to or approved by North Texas, if it is within the transfer window indicated and the player has not registered for the spring.

**Existing Rule:**

3.14.3 Law III - Number of Players and Substitution

- 13U and older shall play 11v11.
- 12U shall play 9v9
- 10U shall play 7v7
- 8U and younger shall play 4v4 with no goalkeeper.

**Proposed Change:**

3.14.3 Law III - Number of Players and Substitution

- 13U and older shall **recommended** play **is** 11v11.
- 12U shall **recommended** play **is** 9v9
- 10U shall **recommended** play **is** 7v7
- 8U and younger shall **recommended** play **is** 4v4 with no goalkeeper
- **Should an association not play in the recommended format, it may limit the teams' ability to participate in inter-association leagues and tournaments, including TOC.**

**New Rule:**

3.14.3 Law III - Number of Players and Substitution

- 13U and older recommended play is 11v11
- 12U recommended play is 9v9
- 10U recommended play is 7v7
- 8U and younger recommended play is 4v4 with no goalkeeper
- Should an association not play in the recommended format, it may limit the teams' ability to participate in inter-association leagues and tournaments, including TOC.

3.14.3 Law III - Number of Players and Substitution

8. Teams shall be allowed the following maximum number of players on its roster at any given time during the seasonal year.

- Adult – maximum 25 players
- 16U and 19U – maximum 22 players
- 14U – maximum 18 players
- 12U – maximum 16 players
- 10U – maximum 12 players
- 8U and younger– recommend 6, maximum 8 players

**8. a** Teams shall be allowed the following maximum number of players on its roster at any given time during the seasonal year.

- 8U and younger– recommend 6, maximum 8 players

**8.b** **Exceptions to these maximum roster sizes may be approved by the appropriate NTSSA Youth or Adult Commissioner. In no case may the roster size be such that all players on a youth recreational team may not get 50% playing time.**

- 8.a Teams shall be allowed the following maximum number of players on its roster at any given time during the seasonal year.
- Adult – maximum 25 players
  - 16U and 19U – maximum 22 players
  - 14U – maximum 18 players
  - 12U – maximum 16 players
  - 10U – maximum 12 players
  - 8U and younger– recommend 6, maximum 8 players
- 8.b Exceptions to these maximum roster sizes may be approved by the appropriate NTSSA Youth or Adult Commissioner. In no case may the roster size be such that all players on a youth recreational team may not get 50% playing time.

**Existing Rule:**

**6.4 POLICY FOR RECREATIONAL TOURNAMENT OF CHAMPIONS**

- 6.4.1 Only one boys' team and one girls' team **PER** age group per association allowed.
- 6.4.2 No Guest Players allowed.
- 6.4.3 At least 75% of the players on a team's roster must be from within the territory of the association that the team represents. The only exceptions to this rule are:
  - a. A team that has played in the association that the team represents for at least two years is exempt from this rule.
  - b. A player whose territorial association does not offer his age group is exempt from this rule
- 6.4.4 Rosters are frozen on the date specified by **NTSSA**.
- 6.4.5 A team playing up during the Fall playing season will not be allowed to come back to their own age group and play at the younger level of the Tournament of Champions (Example: a 10U team plays up in the 12U age group during the fall playing season. That team will not be allowed to come back down and participate in the 10U age group in the Tournament of Champions. They may, however, represent the 12U level if their association so allows).
- 6.4.6 If your Home Association has a league for a team to play in and that team obtains a release from their home association to play in another association or league, that team is not eligible for the Tournament of Champions.
- 6.4.7 The Tournament of Champions shall be organized according to the Small-Sided Games for 10U and 12U age groups utilizing the **NTSSA** Rules of Competition.

- 6.4.6 If your Home Association has a league for a team to play in and that team obtains a release from their home association to play in another association or league, that team is not eligible for the Tournament of Champions.

- 6.4.7 The Tournament of Champions shall be organized according to the Small-Sided Games for 10U and 12U age groups utilizing the NTSSA Rules of Competition.
- 6.4.8 **Teams must play in a recreational league sanctioned by NTSSA.**
- 6.4.9 **Teams that play in any competitive league are not eligible.**
- 6.4.10 **In case of conflict the NTSSA Cup & Games Committee reserves the right to determine a team's eligibility.**

- 6.4.1 Only one boys' team and one girls' team **PER** age group per association allowed.
- 6.4.2 No Guest Players allowed.

- 6.4.6 If your Home Association has a league for a team to play in and that team obtains a release from their home association to play in another association or league, that team is not eligible for the Tournament of Champions.
- 6.4.7 The Tournament of Champions shall be organized according to the Small-Sided Games for 10U and 12U age groups utilizing the **NTSSA** Rules of Competition.
- 6.4.8 Teams must play in a recreational league sanctioned by **NTSSA**.
- 6.4.9 Teams that play in any competitive league are not eligible.
- 6.4.10 In case of conflict the **NTSSA** Cup & Games Committee reserves the right to determine a team's eligibility.
